In consideration of being permitted to participate in the Home Education Associational Resources, Inc. (hereinafter referred to as "HEAR") Activities, the Participant(s) listed here: \_\_\_\_\_

(hereinafter referred to as "Family") agree to the following:

1. Release, waive, discharge, and covenant not to sue the HEAR, the officers, owners, employees, board members or other families participating in the Activities (herein after referred to as "Releasees") from all liability to Family for any loss or damage and any claim or damage on account of injury to the person or property or resulting in the death of a Family member while Family is participating in the HEAR Activities or any other activities on the premises of a HEAR Activity.
2. Family agrees to indemnify Releasees from any loss, liability, damage or cost Releasees may incur due to the presence of Family in or on the HEAR Activity premises. Family releases transportation to and from the Activities or any time off the premises is the Family's responsibility.
3. Family assumes full responsibility for and risk of bodily injury, death or property damage while in or on the premises of a HEAR Activity and/or while working or for any purpose participating in Activities.
4. Family expressly agrees that this release, waiver and indemnity agreement is intended to be as binding and inclusive as permitted by the laws of the State of Texas and that, if any portion of the agreement is held invalid, it is agreed that the balance shall; notwithstanding, continue in full legal force and effect.
5. Family, in consideration of being permitted to participate in the Activities, for Family, and Family's heirs, executors, administrators, and assigns, releases and forever discharges all Releasees, and their heirs, administrators, and executors of and from any and every claim, demand, action or right of action, of whatsoever kind or nature, either in law or in equity arising from or by reason of any bodily injury or personal injuries known or unknown, death or property damage resulting or to result from any accident which may occur as a result of participation in any HEAR Activities.
6. Family releases all officials and professional personnel from any claim whatsoever on account of first aid, treatment or service rendered during participation in the HEAR Activities.
7. HEAR operates under Biblical guidelines and believes that the Bible commands them to make every effort to live at peace and to resolve disputes with each other in private or within the Christian church (Matthew 18:15-20, I Corinthians 6:1-8). Therefore, the parties agree that any claim or dispute arising from or related to this agreement shall be settled by biblically based mediation. The parties understand that these methods shall be the sole remedy for any controversy or claim arising out of this agreement or any dispute arising out of any activities or events associated with the HEAR and expressly waive their right to file a lawsuit in any civil court against one another or against another Family participating in the Activities for such disputes, except to enforce an arbitration decision.
8. Family will act in such a way that their words and actions promote the unity and encouragement of fellow HEAR families. Family will avoid acting in such a way that is considered disrespectful, offensive, immoral, intimidating or rude.
9. We believe that the call to modesty comes directly from scripture and honors Christ. Adults and children should dress modestly at any HEAR Activity. Shorts and skirts should be fingertip length or longer. Shirts should have no bare midriffs or backs, nor spaghetti straps. Clothing should not be sheer and undergarments should not be visible outside of clothing. Clothing should not display inappropriate or suggestive language or designs. HEAR reserves the right to turn away a participant from any Activity for not abiding by the HEAR Dress Code or Code of Conduct.
